## **House to House Solicitiation**

(per Town Code 116-4 through 116-10)

The Stratford Police Department requires that any company that would like to apply for a House-to-House Solicitation Permit must provide the following:

- A Letter of Intent. Must be written on company letterhead. The letter should include what
  your company is going to solicit in the town to the residents. Please include how many
  employees and for how long your company plans to be in town. Make sure supervisor's
  name and number is provided in the letter.
- 2. A copy of your company's Connecticut State Tax ID certificate.
- 3. Each employee must fill out the application and provide a current driver's license or stateissued ID.
- 4. Each agent must pay a non-refundable application fee of \$50.00 for each licensing period. Each licensing period is six months long.

Fee is payable with guaranteed funds only. No personal or company checks.

Once the above requirements are met, mail the information to the following address:

You may bring the information to the police department during Records Division business hours:

Tuesday through Friday from 9 am to 4 pm

Be aware that you may NOT being soliciting in the Town of Stratford until you have been approved and issued a permit. The Lieutenant of Records will contact you when you can pick up your permit. If you being to solicit without a permit in the Town of Stratford, you will be issued a ticket and your permit will be denied approval.
