## House to House Solicitation

(per Town Code 116-4 through 116-10)

The Stratford Police Department requires that any company that would like to apply for a House-to-House Solicitation Permit <u>MUST</u> provide the following:

- A Letter of Intent. Must be written on company letterhead. The letter should include what your company is going to solicit in the town to the residents. Please include employee's name and for how long the company will be in town. Make sure the supervisor's name and phone number is provided in the letter. One employee name per letter of intent.
- 2. A copy of your company's Connecticut State tax ID certificate
- 3. A certificate of liability insurance
- 4. Each employee must fill out the application and provide a current driver's license or state-issued ID. Please include local address of where the employee is staying if they are not a local resident.
- 5. Each employee must pay a non-refundable application fee of \$50.00 (Cash, exact change or check made out to the Town of Stratford) for each six-month licensing period.

Applications can be dropped to the Stratford Police Department Records Division, 900 Longbrook Ave, Stratford, CT 06614. Appointments are not required but are highly encouraged in order to ensure adequate time for the staff to review the application packet before submitting it to the Records Lieutenant for background investigation and approval. The Records Division is open Tuesday through Friday from 9 am to 4 p.m. They are closed on weekends, Mondays and holidays.

Be aware that you are NOT allowed to solicit in the Town of Stratford until you have been approved and issued a permit. The Records Lieutenant or Records staff will contact you by phone when your permit is approved. If you are found soliciting in town without a permit, your permit will be denied and you will be issued a ticket.
